

COVID-19 WAIVER
(not fully vaccinated)

I attest that:

I have NOT been fully vaccinated for COVID-19.

I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.

I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.

I have not been diagnosed with Coronavirus/COVID-19 or have not yet cleared as noncontagious from a previous infection by state or local public health authorities.

I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I have not traveled internationally or to a highly contagious area within the United States in the last 14 days.

I acknowledge the following:

The contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities still recommend practicing social distancing.

The Pinnacle Center has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19 to include the following:

- Clients will not use the waiting rooms but instead will wait in their vehicles until 2-3 minutes before the session start time.
- There will be no shaking of hands, hugging, or otherwise having physical contact with each other.
- Providers and clients will maintain a 6-foot distance from each other
- Masks are required to be worn by all people in session unless all have been fully vaccinated
- Hand sanitizer will be available in the office
- All surfaces touched during a session (e.g., doorknobs, furniture, faucet) will be sanitized in between sessions
- Touch free soap dispensers and automatic hand dryers have been installed in bathrooms

- Parents are responsible for bringing and removing all play items for children

The Pinnacle Center cannot guarantee that I will not become infected with the Coronavirus/COVID-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, The Pinnacle Center staff, and other clients and their families.

I voluntarily chose to be in-person at The Pinnacle Center facility and I understand that in doing so I am increasing my risk to exposure to the Coronavirus/COVID-19. I will comply with all set procedures to reduce the spread while there.

I hereby release and agree to hold The Pinnacle Center harmless from, and waive on behalf of myself, any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of The Pinnacle Center, or that may otherwise arise in any way in connection my presence at The Pinnacle Center. I understand that this release discharges The Pinnacle Center from any liability or claim that I, my heirs, or any personal representatives may have against the practice with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any time I am located at The Pinnacle Center facility. This liability waiver and release extends to The Pinnacle Center together with all its owners, providers, and employees.
